Personal Data

schuetzenhofer.de takes the protection of your personal data very seriously. We treat your personal data confidentially and in accordance with the statutory data protection regulations and this privacy statement.

The use of *schuetzenhofer.de* is possible without providing personal data. These connections are anonymously recorded as guests for the necessary internal logging, e.g. in order to reject junk emails.

To order parts from eShop *schuetzenhofe.de* you have to register and login. For this purpose we save your name, your address for shipment, your fon-no. for possible call backs and perhaps your eMail, to pass your order correctly and most quickly.

We use your personal data without exception for earmarked realisation of your order. Less than ever we give your personal data without your explicit consent to external companies or organisations.

Informations about special sale, improvements or common messages we only send to your eMail if we have received your consent – and you can revoke this any time.

***schuetzenhofer.de* is free of advertising**

On *schuetzenhofer.de*, there are no areas the content of which is not controlled by us, but by third parties, and which could be used for data storage and user logging.

***schuetzenhofer.de* is free of services and content of any third parties and also of user trackers**

schuetzenhofer.de does not use traffic analysis services such as Google Analytics or similar services.

schuetzenhofer.de does not use advertising services such as Google AdSense or similar services.

schuetzenhofer.de has no redirect buttons to social networks on its pages – also no hidden or invisible functions within the only reason to spy on users.

schuetzenhofer.de does not use PayPal or other payment services.

schuetzenhofer.de uses only the minimum connection logging mechanisms contained in the Drupal CMS system used, which serve to prevent risks and to ensure security of *schuetzenhofer.de*. This applies, in particular, to unauthorised login attempts, attempts to place Trojans or other malware in *schuetzenhofer.de*, to prevent *schuetzenhofer.de* from being called, to cause it to crash, to manipulate content or even to delete it.

You can check this, for example, with the free AddOn Privacy Badger for the Firefox browser from the Electronic Frontier Foundation (EFF).

Connection-logs of the CMS-system will be deleted irregular by *schuetzenhofer.de*.

Contact form / recommendation mails

If you send *schuetzenhofer.de* enquiries via the contact form or if you recommend *schuetzenhofer.de* site to someone by email, your details from the email form, including the contact data you provided there, will be stored for the purpose of processing the enquiry and in the event of follow-up questions with us, and will be deleted on a

regular basis. We will not pass on these data without your consent.

Cookies

schuetzenhofer.de - like most web sites - uses so-called cookies. Cookies are small data-snippets which are saved on your device from your browser and are sent back to the *schuetzenhofer.de*-server at the next call of a page. By this, the server could realize functions of your browser so that i.e. a menu or a shopping cart could be enabled. Cookies do not cause - by the current state of knowledge - any damage to your computer and do not contain any viruses. Within functions of your browser you can look at and delete cookies.

schuetzenhofer.de uses exclusively session cookies:

- The *has_js* cookie checks whether JavaScript is activated in your browser. JavaScript is required for the menu system and other functions at *schuetzenhofer.de* and is automatically deleted when you end your browser session.
- For registered users there will be set a cookie at login (i.e. *SSESS...*) that will be deleted at logout. The purpose of this cookie is to identify the customer and allocate the necessary rights to him.

schuetzenhofer.de does not use any cookies that are permanently stored on your terminal device, e.g. cookies that may recognise you during your next visit.

SSL encryption

schuetzenhofer.de uses exclusively SSL encryption for security reasons and in order to protect the transmission of all content. You can recognise an encrypted connection by the fact that the address line of the browser changes from "http://" to "https://" and by the lock symbol in the address line.

Server log files

schuetzenhofer.de is hosted by a provider we know personally, who does not have any agreements regarding the transmission of data with intelligence services or other public or private organizations or companies.

The internet server from which the *schuetzenhofer.de* pages are offered automatically stores information that your browser transmits to the server operator when the page is called up in so-called server log files. These are:

- date and time of your inquiry
- host name or IP of the accessing computer
- operating system used by your browser
- browser type and browser version
- URL of the web site from which you visited *schuetzenhofer.de*

These data are anonymised and cannot be assigned to specific persons. Sporadically the provider of *schuetzenhofer.de* had to check these data subsequently if we become aware of concrete indications of an illegal use of *schuetzenhofer.de* or if this is necessary for the functioning of *schuetzenhofer.de*.

schuetzenhofer.de will never combine the logs of the provider with other data sources.
